

City of Gainesville, Florida Business Impact Estimate

Proposed ordinance's title/reference: ORDINANCE NO. 2023-672
An ordinance of the City of Gainesville, Florida, amending Section 18-18 - Listing of city parks, to add Lincoln Yard Park, rename certain parks, and correct a scrivener's error for the spelling of Loblolly Woods Nature Park; providing directions to the codifier; providing a severability clause; providing a repealing clause; and providing an immediate effective date.

The proposed ordinance 1) amends names of some parks to add "nature" to the ones that are nature parks, thus providing clarity to the public about the activities contained within the park; 2) renames Forest Park to Abby Wambach Park; and 3) adds a new park, Lincoln Yard Park, to the list.
