<u>City of Gainesville, Florida</u> Business Impact Estimate

Proposed ordinance's title/reference: Ordinance No. 2024-834

An ordinance of the City of Gainesville, Florida, amending Article V of Chapter 23 of the Code of Ordinances relating to obstructions and prohibited activities on public property and rights-of-way, including public camping or sleeping; amending Section 2-339 of the Code of Ordinances providing for enforcement; providing directions to the codifier; providing a severability clause; providing a repealing clause; and providing an effective date.

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes. d. Section 633.202, Florida Statutes, relating to the Florida Fire Prevention Code.

In accordance with the provisions of controlling law, even notwithstanding the fact that an exemption noted above may apply, the City hereby publishes the following information:

Consistent with §125.0231, F.S., this ordinance makes it unlawful for any person or entity to engage in any public camping or sleeping, as defined in the ordinance, on any public property or right-of-way.

2. An estimate of the direct economic impact of the proposed ordinance on private, forprofit businesses in the City of Gainesville, if any:

(a) There is no direct economic impact or direct compliance costs imposed by this ordinance on private for-profit businesses. The compliance cost will be borne by the City of Gainesville.

(b) There are no new charges or fees imposed on private for-profit businesses; and,

(c) The ordinance will be enforced utilizing the City's existing resources. These resources are already allocated to addressing right of way and public property issues.

3. No businesses would be directly or likely impacted by the proposed ordinance. However, some indeterminate businesses may be indirectly benefitted by the prohibition on public camping or sleeping on public property and rights-of-way.

4. Additional information the governing body deems useful (if any): Most of §125.0231, F.S., went into effect on October 1, 2024, but subsection (4) of the statute, which provides for civil actions against local governments for violations of the statute, goes into effect on January 1, 2025. This ordinance will provide a local enforcement mechanism relating to the statute, allowing the City to enforce against public camping or sleeping on any public property or right-of-way.
